- Discussion and recalled to previous meeting progresses by Daw Ai Ai Khaing (Community Relationship Officer/MJTD)
 - Thida Myaing school compound had been done earth filling and compaction. The drain has also implemented.
 - No.2 High School(Kyaut Tan) requested the computers and desks for the students and it hadn't provided yet. We will visit to the school and have the detail discussion for the necessary provision.
 - And TSEZ had provided stationary to almost 2700 students from neighboring villages. By taking the chance, she would like to discuss with the leaders of the different villages for the strategy of stationary supporting program. For 2018 and past, our strategy focus to recipients who directly or indirectly effected by TSEZ project development. They are untitled to get full support for their whole academic year. But some complaints came to TSEZ from those who didn't get the supporting. TSEZ also had budget limitation and it cannot be covered the whole area of Thanlyin-Kyaut Tan. So that we would like to discuss here whether the budget of each candidate should be reduced and support more number of students than before or as usual strategy.
 - And TSEZ will also support the school building and necessary facilities to Aye Mya Thida School. Our intention is to benefits the students not only from Aye Mya Thida ward but also students from neighboring villages such as Shwe Pyi Tharyar ward and Shwe Pyaut village tract. During these years, TSEZ supports were more on education area such as human resource development especially for next generation because they plays an important role in country development.
- Discussion and comments from representatives of Addutaw village
 - TSEZ should take care and relevant action by having negotiation with the squatters from the Eastern Road for different reasons. E.g. the fencing construction work and drain construction cannot be continue due to some squatters'houses which were constructed on the drain .It affect to the Addutaw village's drain system as a consequent the village become flood. That's why TSEZ should resolved that issue as soon as possible and community is also ready to support.

- The new school building for Addutaw village had been approved to construct with government budget but the desks and chairs were not included. That's why TSEZ are requested to support the necessary school facilities.
- Regarding with the stationary donation program, TSEZ should give equal number to schools and the school management will manage to provide to the students who do not really afford.
- Discussion and comments from representative of Thida Myaing village tract
 - Suggested to support more number of students than before with relevant quality of stationary in 2019 program. For his opinion, very good quality is not quite important in education.
- Discussion and comments from representative of Shwe Pyaut village tract
 - > Suggested to install the traffic light at the junction of Eastern road
- Discussion and comments from representative of Shwe Pyi Tharyar ward
 - Requested ferry transportation for the students for daily commute from Shwe Pyi
 Tharyar ward to Kyauut Tan
- Discussion and comments from representative of Myaing Tharyar village
 - Requested to support in maintenance of preschool roofing. It became leakage during rainy season.
 - Shared that it has some problems to manage and administer the project affected households from relocation site. The relocation area is located inside Nyaung Wine village tract and the PAHs are under the management of Nyaung Wine tract administration. But some people are thinking as they are the under the management of TSMC and not under the relevant village administration. So that TSEZ management should take relevant action for this particular case.
- Comments from Daw Ai Ai Khaing (Community Relationship Officer, MJTD)
 - Daw Ai Ai Khaing explained the current status of squatter issue; the squatters were sued by Ministry of Construction as they were staying road area. The court will make the decision and it may take some time.
