First, Zone B development construction, we have still some pending issue but we have already started construction in Zone B Phase 3 new development area from last month. This is the dry season, we try to immediate dust pollution sometimes we saw, we got dusty, so we are very afraid such as dust and afraid for surrounding area. So, if you have any problem, please be freely contact for complaint through TCMP. Now, we have 68 locators who already started their operation in Zone A and Zone B. At the end of December last year, we increased the number of recruitments by more than 60 locators. The number is more than 8500 people. With both our locators increased the number of employments in this year, we increasing their production. But, if you have any programs of difficulties, please share in this meeting.
